#### **Chairman Report**

- Debbie Meihls Annual Review: Chair Baker reviewed the reviews by board members and summary of accomplishments of Mrs. Meihls. All board members commented that Mrs. Meihls does an outstanding job and appreciation of her forward progress. Donna Ruby presented the financials for April, May, June, July and August. All expenses as planned and referenced the interest year to date. Financials are filed for audit that will begin November 2024.

Meeting was Recessed at 10:55 AM and reconvened at 11:15 AM.

#### **CEO Report:**

Mrs. Meihls toplined the budget meetings of August 20, 2024, and September 17, 2024.

- 1. Reference CPA RSQ, Advertising RSQ, Digital RSQ as well as IT Services RSQ are on and will be on the street wrapping up before February 2025.
- 2. Ms. Meihls referenced over 58 Journalist, TV Crews, and other media invited to the destination in FY 23/24. Most ever hosted.
- 3. \$80K -\$105K Research Budget from Downs St. Germain for FY24/25. Discussion and Approval for \$80k-\$105k for Research Motion made by Richard England and 2<sup>nd</sup> Chad Truxall, All Approved.
- 4. \$100k will be allocated to Airline marketing in destinations of Avelo and Breeze Airways per Volusia County Council meeting 9/17/24. Motion made to approve \$100k Funding by Chad Truxall and 2<sup>nd</sup> Motion by Jamie Dudley, All in Favor. This from the FY 24/25 Budget of \$6,326,254.
- 5. Relebrand presented online and digital ROI for FY 23/24 and showed the increase to top feeder markets.
- 6. ITI Digital presented website, social media and newsletter campaigns and resulting ROI for FY 23/24 and future planned digital.
- 7. Pineapple PR presented FY23/24 Earned media value of \$27 Million in Earned Media. Showcased FY24/25 plans for top feeder markets.
